As a community member who has been organizing against this project since its inception, it should be noted that the comments against this project have been consistent and growing in complexity making many of our community leaders greater experts on the topic then the staff and representatives making the ultimate decisions. This often happens when individuals take the time to read and digest the contents of an EIR...

The last-minute call to hold a decision-making meeting on Valentine's Day and dropping a 200-page load of nonsense to review during the Lunar New Year celebration, shows a profound lack of respect for the people being impacted.

Our petition has grown to over 6,000 signatures as of this morning... (An updated copy will be provided to the full board for next week) not from people who have been paid by McCourt, but by people living, working, and participating in the collective community. They answered substantive reasons to the petition they signed vs "I like the Gondola" from LA ART. Newspapers, activists, engineers, community leaders, environmentalists, conservationists, have all weighed in on the absurdity of allowing this project to move forward.

It has not been lost on us that Metro and most of the electeds involved in approving or disapproving this project speak incessantly about the need to make our neighborhoods and parks more equitable, so it would incumbent upon our elected leaders to explain to the community how giving a billionaire a blank check to build a (unfunded) 500 million dollar monstrosity that will serve only his needs, serves our community.

We get:

- Thousands of pounds of concrete added to the neighborhood.
- Peepers hovering 26 feet above our park and our homes at all hours of the day.
- The removal of hundreds of mature shade giving trees in a protected historic state park
- Loss of community and park parking
- More traffic
- Loss of park vistas and public air space

Just to name a few.

Equity begins with listening to and siding with the communities of color being subjected to assaults on their neighborhood by billionaires like Frank McCourt. Equity is not something we ignore no matter who and how much money is being promised.

This is the very nature of Equity; PROTECTING COMMUNITIES FROM THIS EXACT THING. How many more destructive incidents will be tied to this stadium and Frank McCourt? This has to stop.
